For All Women and Girls - Climate Justice

A meaningful just transition is only feasible through leveraging women's and girls' knowledge and leadership. The Feminist Action for Climate Justice Action Coalition within the Generation Equality initiative amplifies the voices of women and girls in climate action, especially in grassroots communities. Its collective aim is to enable a transition to an inclusive, circular, regenerative green economy that integrates climate justice, prioritizing gender-responsive climate finance, women-led sustainability solutions and resilience-building. This can be achieved through the meaningful participation and voice of women and girls, as well as improved gender and environment data, which are a prerequisite to fulfill the Beijing+30 Action Agenda on climate justice.





SHOWCASED PRACTICES

Green Climate Fund Projects Advance Gender Integration (Republic of Korea)

Since the adoption of the Updated Gender Policy in 2019, 122 Green Climate Fund (GCF) projects have been endorsed, all with genderresponsive assessments and Gender Action Plans. Of 243 projects in portfolio, 96.3% of GCF investments are gender-responsive. The GCF remains committed to supporting gendercontinuous improvement in responsive projects.

ACNDC Engages Women in Climate Action and Conservation (Democratic Republic of the Congo)

Actions for Nature Conservation and Development Community (ACNDC) organized three land-based expeditions, equipping over 105 women with climate information. The initiative led to the development of participatory community maps and three landscape restoration and conservation plans, strengthening women's involvement in climate action across South Kivu and North Kivu.

IFAD Financing Program ASAP+ Empowers Smallholder Farmers Worldwide (HQ in Italy)

ASAP+ (Adaptation Smallholder for Agriculture Programme Plus) has mobilized US\$92.1 million, supporting 10 investment projects to help smallholder farmers adapt to climate change. While no funds were raised last year due to IFAD13 replenishment campaigns, mobilization will resume. Disbursements have supported 20,000 family farms in Brazil, benefiting Indigenous communities, women, and youth, and strengthened smallholder farmers' access to irrigation and markets in Malawi, focusing on women's empowerment.
